Huddersfield Psychologist Wins Innovator of the Year

A Huddersfield Psychologist has won Innovator of the Year at a national awards ceremony for his work supporting those struggling with their mental health.

Dr Majid Saleem is Head of Psychology at Gledholt Mews and Coach House, a residential service for adults in Huddersfield with mental health needs or a personality disorder who have been able to progress through the hospital pathway and are looking for the next stage in their rehabilitation journey.

Dr Saleem was singled out during the Cygnet Annual Psychologists Conference and National Awards 20223 for his commitment to innovation and delivering consistently high standards of care.

Organised by Cygnet Health Care, one of the UK's leading health and social care companies offering services to those with mental health needs, learning disabilities and autism, the Innovator of the Year award celebrates the innovation that is leading the way in delivering better services, empowering staff teams and improving the quality of care provided for service users.

The APDP is a structured development programme for Assistant Psychologists employed across Cygnet that aims to develop professional knowledge and in turn increase the quality of care that is provided to service users. It offers development opportunities across two streams: online lectures and interactive workshops.

Upon receiving the award, Dr Saleem said: *"I am truly honoured to receive the award. I would like to say a huge thank you to my fellow APDP colleagues for all their fantastic work, this was a real team effort."*
