# **Nottingham Doctor Wins Innovator of the Year**

A Nottingham doctor has won Innovator of the Year at a national awards ceremony for her work to improve the lives of those struggling with severe and enduring mental illness.

Dr Sree Thamburaja, Consultant Forensic Psychiatrist at Cygnet Hospital Clifton, an inpatient mental health hospital for men, was singled out during the Cygnet Annual Psychiatrists Conference and National Awards 2023.
