## West Midlands Care Manager Wins Great British Care Award

A BIRMINGHAM manager who supports individuals with learning disabilities, mental health needs and autism has been named Supported Living Manager of the year at a prestigious awards event.

Leanne Squires is the registered manager of Staffordshire Supported Living which supports individuals living with learning disabilities, mental health needs and autism offering personal care within their own homes across the West Midlands. The service, part of the Cygnet Social Care division, supports individuals in their own homes in Bordesley Green, Birmingham and in Wombourne, near Wolverhampton.

She scooped the Supported Living Manager Award at the Great British Care Awards which pay tribute to individuals and teams who have demonstrated outstanding excellence within their field of work. The award recognised the manager who shows vision in developing person centred care and supporting staff to meet the ever changing needs of the residents.

A spokesperson for the Great British Care Awards said: "I was blown away by the way Leanne not only went above and beyond for the service users but her staff too. The creative ideas all to try to have the service a harmonise place to work which then reflects in the care is truly inspirational."
