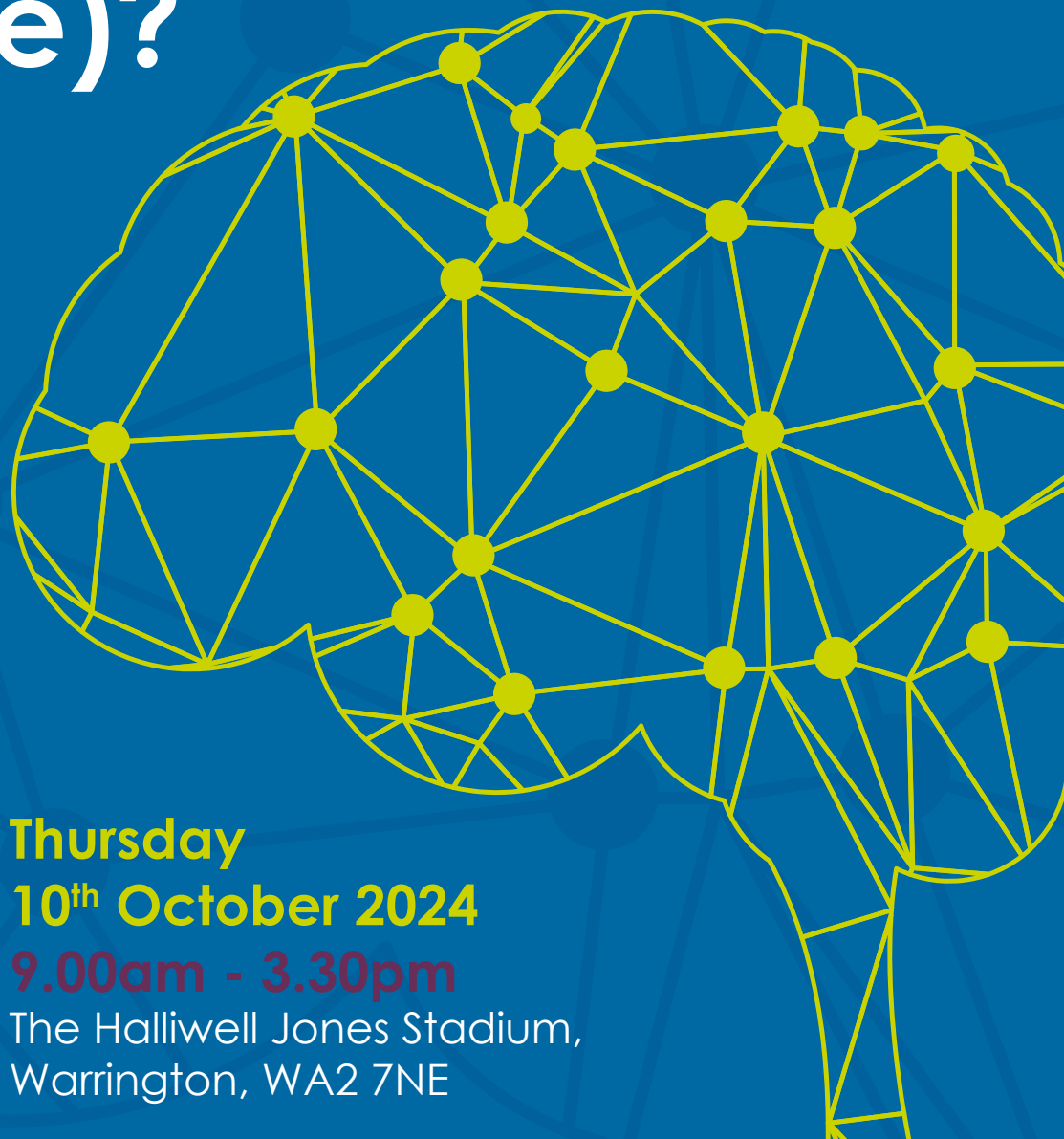

## **Managing Risk in Complex Neurorehabilitation**

## **How Professional Backgrounds Influence Approach to Mental Capacity Act Assessments**

We have set out to explore in more detail how various professional backgrounds influence approaches to the complexity of Mental Capacity Act assessments. We used a thematic analysis approach to analyse the qualitative experience of Psychiatrists, Psychologists, Speech and Language Therapists and Occupational Therapists within our service in a pilot study.

## **“A good death”: A team approach to supporting someone with Wilson's Disease**
